TRIAL CHAMBER II (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”):

NOTING the “Prosecution Motion to Present Rebuttal Evidence in Pursuant to Rule 85 (iii)” (“Motion”) filed confidentially by the Office of the Prosecution (“Prosecution”) on Tuesday 24 January 2006 pursuant to Rule 85 (A)(iii) of the Rules of Procedure and Evidence of the Tribunal (“Rules”);

NOTING the Trial Chamber’s oral Scheduling Order during the proceedings of this case on Wednesday 25 January 2006, which, *inter alia*, established the time for the Defence for Naser Orić (“Defence”) to respond to the Motion as no later than Tuesday 31 January 2006;

NOTING the “Addendum to the Prosecution Motion to Present Rebuttal Evidence Pursuant to Rule 85(iii)” (“Addendum”) filed confidentially by the Prosecution on Friday 27 January 2006;

CONSIDERING that, as the Addendum contains new submissions, it is appropriate to grant the Defence additional time to respond to the Motion as supplemented by the Addendum;

CONSIDERING the time for filing responses to motions prescribed in Rule 126*bis* of the Rules;

PURSUANT TO Rules 126*bis* and 127 of the Rules;


