I, Carmel Agius, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

HAVING DESIGNATED MYSELF pre-trial Judge in the case of *Prosecutor v. Vujadin Popović*, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Zdravko Tolimir, Radivoje Miletić, Milan Gvero, Vinko Pandurević and Milorad Trbić, Case No. IT-05-88-PT;¹

NOTING Rule 65bis of the Rules of Procedure and Evidence of the Tribunal ("Rules") which provides, *inter alia*, that a status conference shall be convened within one hundred and twenty days after the last status conference to i) organise exchanges between the parties so as to ensure expeditious preparation for trial; and ii) to review the status of his or her case and to allow the accused the opportunity to raise issues in relation thereto, including the mental and physical condition of the accused;

NOTING that the last Status Conferences in the present case took place on 10 November 2005;

NOTING the "Scheduling Order for a Status Conference and Further Appearance of the Accused", issued on 7 February 2006, in which a Status Conference was announced to take place on Tuesday 7 March 2006;

CONSIDERING however, that unforeseen justified circumstances have led to the need to postpone the Status Conference;

PURSUANT TO Rules 50, 54 and 65bis of the Rules;

HEREBY ORDER

1. that a Status Conference for the Accused Vujadin Popović, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Radivoje Miletić, Milan Gvero, Vinko Pandurević and Milorad Trbić shall now be held on Tuesday 04 April 2006 at 14.15; and that

2. during the course of the Status Conference, the Accused Vujadin Popović, Ljubiša Beara, Drago Nikolić, Ljubomir Borovčanin, Vinko Pandurević and Milorad Trbić shall enter pleas of guilty or not guilty on the new charges sought to be included by the Prosecution in the Consolidated Amended Indictment, as set out in the Scheduling Order of 7 February of this year.
