

I, Jean-Claude Antonetti, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

HAVING BEEN DESIGNATED as pre-trial Judge in this case pursuant to an Order rendered by Trial Chamber II on 31 October 2005;

CONSIDERING rules 65 *bis* (A) and 65 *ter* (B) of the Rules of Procedure and Evidence ("Rules");

WHEREAS pursuant to Rule 65 *bis* (A) of the Rules, an order of 22 February 2006¹ scheduled a status conference for 12 April 2006;

WHEREAS the trial is due to commence shortly and the Prosecution requested an additional status conference be held prior to the one scheduled for 12 April 2006²;

WHEREAS it is incumbent upon the Pre-Trial Judge to best manage the preparation of the case and encourage exchanges between the parties, thereby settling any pending issues prior to commencement of the trial;

FOR THE FOREGOING REASONS

ORDER that an additional status conference be held on 30 March 2006 from 09:00 to 12:00.
