NOTING "Serbia and Montenegro's Submission for Redaction of Certain Parts of the Trial Chamber's 'Decision on Applications of Prosecution and Serbia and Montenegro Pursuant to Rule 54*bis*' Issued on 9 December 2005," filed confidentially by the government of Serbia and Montenegro on 15 March 2006 ("Submission");

NOTING further "Serbia and Montenegro's Motion to Vacate or Indefinitely Suspend the Trial Chamber's 'Decision on Applications of Prosecution and Serbia and Montenegro Pursuant to Rule 54*bis*' Issued on 9 December 2005," filed confidentially by the government of Serbia and Montenegro on 15 March 2006 ("Motion");

RECALLING the "Order Terminating the Proceedings," issued by Trial Chamber III on 14 March 2006, terminating all trial proceedings in *Prosecutor v. Milošević*, Case No. IT-02-54-T, due to the death of Slobodan Milošević;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

HEREBY ASSIGN, effective immediately, Trial Chamber III to consider the Motion and Submission filed by Serbia and Montenegro in the *Milošević* case on 15 March 2006.
