I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”),

NOTING the “Order Reassigning a Case to a Trial Chamber” of 31 October 2005 in which Trial Chamber II was assigned to the present case;

NOTING the composition of Trial Chamber II as set out in document IT/242 issued on 17 November 2005;

NOTING the letter of the Secretary-General of 31 March 2006, in which Judge Stefan Trechsel is appointed to serve in the International Tribunal for the trial of this case, effective 3 April 2006;

NOTING the letter of the Secretary-General of 31 March 2006, in which Judge Árpád Prandler is appointed to serve in the International Tribunal for the trial of this case, effective 3 April 2006;

NOTING Article 12(2), Article 13 *ter* (2), and Article 14(5) of the Statute of the International Tribunal;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;
