I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 ("International Tribunal"),

NOTING the "Order Assigning a Case to a Trial Chamber" issued on 20 September 2005, which assigned this case to Trial Chamber I;

RECALLING that on 29 November 2005, pursuant to Article 13*ter*, paragraph 2, of the Statute of the International Tribunal, the Secretary-General of the United Nations appointed Judge Frank Höpfel and Judge Janet Nosworthy to serve as *ad litem* Judges in this case;

NOTING the "Order Terminating the Proceedings" issued by Trial Chamber III on 14 March 2006, terminating all proceedings in the trial of Slobodan Milošević due to the death of the Accused;

NOTING that on 20 April 2006, the Secretary-General withdrew his appointments of Judge Höpfel and Judge Nosworthy to this case in light of the re-organization of the International Tribunal's caseload;

CONSIDERING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

HEREBY ASSIGN, effective immediately, Case No. IT-95-14 & 14/2-R77, *The Prosecutor v. Josip Jović*, to Trial Chamber III, as it is presently composed.
