I, THEODOR MERON, Judge of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of Former Yugoslavia since 1991 ("Tribunal"), and Pre-Appeal Judge in this case,

CONSIDERING that Haradin Bala ("Bala") has been in detention at the United Nations Detention

Unit ("UNDU") in The Hague pending the decision of the appeals in this case, and that while he has

been on provisional release since 23 April 2006, he is scheduled to return to the UNDU on 27 April

2006, pursuant to the Appeals Chamber's decision of 20 April 2006;

CONSIDERING that Bala filed his notice of Appeal on 30 December 2005. and that the

Prosecution filed its notice of Appeal on the same date;²

CONSIDERING that while Rule 65bis of the Rules of Procedure and Evidence of the Tribunal

requires the convening of a status conference within 120 days of the filing of a notice of appeal,

Haradin Bala and Isak Musliu have consented to have the first pre-appeal status conference held

outside this time period, and counsel for Fatmir Limaj, though unable to contact Mr. Limaj, asserts

that holding the status conference outside the 120 day time period is in Mr. Limaj's interests, and

that he is endeavouring to contact Mr. Limaj to confirm Mr. Limaj's agreement with this

assessment;

ORDER that a status conference shall be held before me on Thursday, 4 May 2006 at 4:30 p.m in

Courtroom 3.
