I. FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the Former Yugoslavia Since 1991 ("International Tribunal"),

BEING SEISED OF the "Motion by the Prosecutor under Rule 11 bis for Referral of the

Indictment," filed on 4 May 2006, in which the Prosecutor requests that this case be referred to the

authorities of Bosnia and Herzegovina pursuant to Rule 11 bis;

NOTING that the Indictment against the Accused has been confirmed; ¹

NOTING that under Rule 11 bis (A)(i) of the Rules of Procedure and Evidence, after an indictment

against an accused has been confirmed, the President of the International Tribunal may appoint a

Referral Bench for the purpose of referring a case to the authorities of a State in whose territory the

crime was committed;

NOTING the Prosecution's submission that the crimes alleged in the Indictment against the

Accused took place in the territory of Bosnia and Herzegovina;²

CONSIDERING the composition of the Trial Chambers of the International Tribunal as set out in

Document IT/242 issued on 17 November 2005;

HEREBY APPOINT, effective immediately, the following Judges to constitute the Referral Bench

for the purpose of determining whether this case should be referred to the authorities of Bosnia and

Herzegovina pursuant to Rule 11 bis:
