I, **Judge Patrick Robinson**, Presiding Judge of Trial Chamber III of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”),

**NOTING** the Indictment in the case *Prosecutor v. Momčilo Perišić*, confirmed on 25 February 2005, by Judge Jean-Claude Antonetti,

**NOTING** that the initial appearance of the Accused Momčilo Perišić took place before me on 9 March 2005, at which time he pleaded not guilty to all counts of the Indictment,

**CONSIDERING** the two Orders issued by the President of the Tribunal on 12 May 2006, assigning Judges Krister Thelin and Frank Höpfel to Trial Chamber III for the purposes of pre-trial work in the present case,<sup>1</sup>

**CONSIDERING** Rule 65ter(A) of the Rules of Procedure and Evidence of the Tribunal (“Rules”), which provides that the Presiding Judge of the Trial Chamber shall “designate from among its members a Judge responsible for the pre-trial proceedings” (hereinafter “pre-trial Judge”),

**HEREBY ORDER** that Trial Chamber III in the case *Prosecutor v. Momčilo Perišić* shall be composed, for the purposes of pre-trial proceedings, as follows:

Judge Krister Thelin


