THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal"),

NOTING the Judgement rendered in this case by Trial Chamber II on 31 January 2005;

BEING SEIZED OF appeals lodged by Mr. Pavle Strugar and the Office of the Prosecutor against the Trial Judgement;

NOTING that the filings for both appeals have been finalized as of 1 September 2005;¹

NOTING that status conferences have been held in this case on 30 June 2005, 06 September 2005 and 12 December 2005;

NOTING the provisional release of Mr. Strugar on 16 December 2005 for medical reasons, during which he was operated upon on 27 December 2005, and was subsequently transferred to a rehabilitation center for post-operative rehabilitation on 23 January 2006;

NOTING that Mr. Strugar complied fully with the conditions of his provisional release and returned to the United Nations Detention Unit earlier than the time granted for post-operative rehabilitation:

NOTING that conferences pursuant to Rule 65ter(i) and Rule 107 were held in this case on 30 March and 11 May 2006;

PURSUANT to Rule 114 of the Rules of Procedure and Evidence of the International Tribunal;

HEREBY ORDERS that a hearing in the present case take place on Thursday, 1 June 2006, commencing at 14:15 in Courtroom III.
