Dragan Gagović, Gojko Janković, Janko Janjić, Radomir Kovac, Zoran Vuković, Dragan Zelenović, Dragoljub Kunarac and Radovan Stanković,* filed on 19 June 1996 with amended pages filed 26 June 1996; the Amended Indictment in *The Prosecutor v. Gojko Janković, Janko Janjić, Zoran Vuković, Dragan Zelenović and Radovan Stanković,* signed on 5 October 1999; and the redacted version of the Amended Indictment in *The Prosecutor v. NOTING that the Registry has advised that Dragan Zelenović ("Accused") has been detained and will be transferred to the seat of the Tribunal pursuant to Rule 62 of the Rules of Procedure and Evidence ("Rules") during the month of June 2006;

NOTING that Rule 62 requires the President of the Tribunal forthwith to assign the case to a Trial Chamber upon the transfer of an accused to the seat of the Tribunal;

NOTING that President Pocar is currently absent from the Tribunal and that pursuant to Rule 21, the Vice-President shall exercise the functions of the President in the case of the latter's absence or inability to act;

CONSIDERING the trial management and case distribution needs of the Tribunal;

CONSIDERING the composition of the Trial Chambers of the Tribunal as set out in document IT/245 issued on 12 May 2006;

HEREBY ASSIGN, effective on the date upon which the Accused is transferred to the seat of the Tribunal, the present case to Trial Chamber I;
