I, MOHAMED SHAHABUDDEEN, Judge of the Appeals Chamber of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "International Tribunal", respectively);

NOTING that the Appeals Chamber is seised of appeals from the Judgement of Trial Chamber II in the case of *Prosecutor v. Hadžihasanović and Kubura*, Case No. IT-01-47, rendered on 15 March 2006 ("Judgement");

NOTING the "Order Assigning Judges to a Case Before an Appeals Chamber and Appointing a Pre-Appeal Judge," filed on 26 April 2006, which appointed me Pre-Appeal Judge in this case;

NOTING that Amir Kubura filed his "Notice of Appeal From Judgement on Behalf of Amir Kubura Filed Pursuant to Rule 108" in this case on 13 April 2006, while Enver Hadžihasanović filed his "Notice of Appeal From Judgement on Behalf of Enver Hadžihasanović and Request to Exceed the Page Limit" on 18 April 2006;

NOTING that although Mr. Kubura was granted early release on 11 April 2006, Mr. Hadžihasanović is in custody at the United Nations Detention Center and is therefore entitled to a status conference by 16 August 2006, within 120 days of the filing of his Notice of Appeal, according to Rule 65 *bis* (B) of the Rules of Procedure and Evidence of the International Tribunal;

CONSIDERING that in order to facilitate the appeal process and in the interests of justice, it is preferable that Mr. Kubura also be represented at the first status conference at the appeal stage;

NOTING that Mr. Hadžihasanović has agreed to accept a short delay in his status conference in order to accommodate scheduling conflicts in the arrangement of a joint status conference;

ORDER that a Status Conference be held for both appellants on Friday, 1 September 2006, at 2:15 PM in Courtroom 1 of the International Tribunal.
