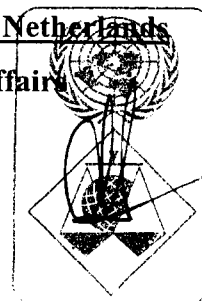


TRIAL CHAMBER I (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

RECALLING the Order in Lieu of Indictment on Contempt Concerning Branko Đerić and the Warrant of Arrest issued by the Trial Chamber on 27 June 2006 and notified to the Government of Bosnia and Herzegovina;

CONSIDERING the oral decision issued by the Presiding Judge on 11 July 2006, in which the Chamber has, in its discretion, decided that it is not in the interests of justice to proceed with the contempt proceedings against Mr Đerić and, therefore, dismissed the indictment and vacated the warrant of arrest;¹

HEREBY NOTIFIES the competent authorities of Bosnia and Herzegovina that the Order in Lieu of Indictment on Contempt Concerning Branko Đerić and the Warrant of Arrest issued by the Trial Chamber on 27 June 2006 are withdrawn;
