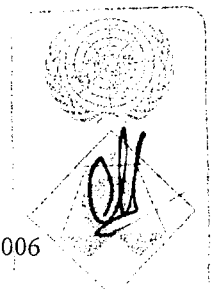

I, **FAUSTO POCAR**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 (“International Tribunal”),

NOTING the “Order Assigning a Case to a Trial Chamber”, issued on 9 March 2004, which assigned the *Čermak* and *Markač* case to Trial Chamber II, composed of Judge Carmel Agius, Judge Jean-Claude Antonetti, and Judge Kevin Parker;

NOTING the “Order Assigning a Case to a Trial Chamber”, issued on 9 December 2005, which assigned the *Gotovina* case to Trial Chamber II, composed of Judge Carmel Agius, Judge Kevin Parker, and Judge Christine Van Den Wyngaert;

NOTING the “Order Referring the Joinder Motion”, issued on 23 February 2006, which assigned the Bench presiding over the *Gotovina* case to hear the “Prosecution’s Consolidated Motion to Amend the Indictment and for Joinder” and all motions related to the joinder of the *Čermak* and *Markač* case with the *Gotovina* case;

NOTING the “Decision on Prosecution’s Consolidated Motion to Amend the Indictment and for Joinder”, rendered by Trial Chamber II on 14 July 2006, which joined Case No. IT-03-73-PT, *Prosecutor v. Ivan Čermak and Mladen Markač* and Case No. IT-01-45-PT, *Prosecutor v. Ante Gotovina*;

NOTING the Certificate issued by the Registrar on 17 July 2006, in which case number IT-06-90-PT was assigned to the joint case *Prosecutor v. Ante Gotovina, Ivan Čermak and Mladen Markač*;

CONSIDERING the composition of the Trial Chambers of the International Tribunal as set out in document IT/245 issued on 12 May 2006;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;


