I, Carmel Agius, Presiding Judge of Trial Chamber II of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

NOTING the "Decision on Motion for Joinder" rendered on 21 September 2005, in which Trial Chamber III joined the cases of *Prosecutor v. Vujadin Popović*, Prosecutor v. Ljubiša Beara, Prosecutor v. Drago Nikolić, Prosecutor v. Ljubomir Borovčanin, Prosecutor v. Zdravko Tolimir, Radivoje Miletić and Milan Gvero, and Prosecutor v. Vinko Pandurević and Milorad Trbić, into one single case bearing case number IT-05-88;

NOTING the "Order Assigning a Case to a Trial Chamber" issued by the President of the Tribunal on 26 September 2005, in which Case No. IT-55-88-PT was assigned to Trial Chamber II ("Trial Chamber");

NOTING the "Decision on Severance of Case Against Milorad Trbić" issued by the Trial Chamber on 26 June 2006, in which the case against Milorad Trbić ("Accused") was severed from that against the eight co-accused in Case No. IT-05-88-PT and in which the Trial Chamber further ordered the Registry to assign a new case number to the severed proceedings against the Accused;

NOTING further the Certificate issued by the Registrar on 27 June 2006 which assigned case number IT-05-88/1-PT to the proceedings against the Accused;

CONSIDERING that Article 13quater(1)(d) of the Statute of the Tribunal ("Statute") enables ad litem Judges of the Tribunal to adjudicate in pre-trial proceedings;

CONSIDERING that Rule 65ter(A) of the Rules of Procedure and Evidence of the Tribunal ("Rules") provides that the Presiding Judge of the Trial Chamber shall designate from among its members a Judge responsible for the pre-trial proceedings ("Pre-Trial Judge");

NOTING the powers of a Pre-Trial Judge as set out in Rule 65ter of the Rules;
