TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

CONSIDERING that at the hearing of 4 October 2006, the Office of the Prosecutor ("Prosecution") moved for the admission of 19 documents and that the counsels for the Accused Praljak ("Praljak Defence") and the counsels for the Accused Ćorić ("Ćorić Defence") moved for the admission of, respectively, 15 and 6 documents relating to the testimony of Peter Hauenstein ("Proposed Exhibits"), 1
