SCHEDULING ORDER FOR A STATUS CONFERENCE

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

NOTING that Trial Chamber II shall be composed, for purposes of pre-trial proceedings in the case of *Prosecutor v. Milorad Trbić*, Case No. IT-05-88/1-PT, of Judge Carmel Agius as Presiding Judge, Judge O-Gon Kwon and Judge Kimberly Prost by order of 3 July 2006;¹

NOTING Rule 65bis of the Rules of Procedure and Evidence of the Tribunal which provides, *inter alia*, that a status conference shall be convened within one hundred and twenty days after the last status conference to i) organize exchanges between the parties so as to ensure expeditious preparation for trial; and ii) to review the status of the case and to allow the accused the opportunity to raise issues in relation thereto, including the mental and physical condition of the accused;

NOTING that the last Status Conference in the present case was held on 15 September 2006;²

CONSIDERING that there are issues that need to be raised with the parties at the present time before the expiry of the one hundred and twenty days since the last status conference;

FOR THE FOREGOING REASONS


PURSUANT TO Rule 65bis;
