1. Vojislav Šešelj ("Šešelj") has filed an Appeal<sup>1</sup> before me against the Deputy Registrar's Decision to assign David Hooper as his Defence Counsel.<sup>2</sup> The Registry responded with a Submission on 1 November 2006.<sup>3</sup> As the Decision of the Trial Chamber on the assignment of counsel<sup>4</sup> which requested the Registry to assign Defence Counsel to Šešelj was overturned by a Decision of the Appeals Chamber,<sup>5</sup> David Hooper is no longer assigned as Defence Counsel to Šešelj. In this circumstance, the Appeal before me is rendered moot.

#### Disposition

2. On the basis of the foregoing, Šešelj's Appeal is **DISMISSED.**
