I, MOHAMED SHAHABUDEEN, Judge of the Appeals Chamber of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”);

NOTING that the Appeals Chamber is seized of appeals from the Judgement of Trial Chamber II in the case of *Prosecutor v. Hadžihasanović and Kubura*, Case No. IT-01-47-T, rendered on 15 March 2006;

NOTING the “Order Assigning Judges to a Case Before the Appeals Chamber and Appointing a Pre-Appeal Judge,” filed on 26 April 2006, which, *inter alia*, designated me to serve as Pre-Appeal Judge in this case;

NOTING that the Appeals Chamber is seized of notices of appeal filed by Enver Hadžihasanović and Amir Kubura;

NOTING that a status conference was last held for Mr. Hadžihasanović on 1 September 2006, at which Mr. Kubura was also represented;


NOTING that although Mr. Kubura was granted early release on 11 April 2006, Mr. Hadžihasanović is in custody at the United Nations Detention Centre and is therefore entitled to status conferences within increments of 120 days according to Rule 65 *bis* (B) of the Rules of Procedure and Evidence;

CONSIDERING that in order to facilitate the appeal process and in the interests of justice, it is preferable that Mr. Kubura also be represented at this second status conference at the appeal stage;

ORDER that a Status Conference be held for both appellants on Monday, 11 December 2006, at 8:00 AM, in Courtroom II of the International Tribunal.
