

I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal"),

NOTING the "Order Reassigning a Case to a Trial Chamber" of 3 May 2006, which assigned Prosecutor v. Vojislav Šešelj, Case No. IT-03-67-PT, to Trial Chamber I, and determined for the purposes of this case, that Trial Chamber I shall be composed of Judge Alphons Orie, Judge Patrick Robinson and Judge Bakone Justice Moloto;

NOTING the "Order Assigning an Ad Litem Judge to a Case before a Trial Chamber" of 31 October, in which Judge Frank Höpfel was assigned to Trial Chamber I for the trial of *Prosecutor v*. Vojislav Šešelj, Case No. IT-03-67-PT, with effect from 1 November 2006;

NOTING the letter of the Secretary-General of 11 July 2006, in which Judge Ole Bjørn Støle is appointed to serve in the International Tribunal as a reserve Judge for the trial of *Prosecutor v*. Popović et al., effective 11 July 2006;

NOTING Security Council Resolution 1481 (2003), which authorized ad litem Judges to adjudicate in pre-trial proceedings in cases other than those they have been appointed to try;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

HEREBY ASSIGN, with immediate effect, Judge Ole Bjørn Støle to replace Judge Patrick Robinson in the present case;

AND ORDER that the Bench in Prosecutor v. Vojislav Šešelj, Case No. IT-03-67-PT, shall be composed as follows:
