TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

WHEREAS during the hearing of 11 January 2007, the Office of the Prosecutor ("Prosecution") requested the admission into evidence of 16 documents, while Counsel for the Accused Prlić ("Prlić Defence"), Counsel for the Accused Stojić ("Stojić Defence"), Counsel for the Accused Praljak ("Praljak Defence"), Counsel for the Accused Petković ("Petković Defence") and Counsel for the Accused Ćorić ("Ćorić Défense") requested the admission into evidence of 7,2 2,3 8,4 15 and 26 documents, respectively, related to the testimony of Witness CR ("Proposed Exhibits");7

WHEREAS the Chamber has heard the objections raised by the Praljak Defence⁸ and Ćorić Defence⁹ with regard to the admission of the documents proposed by the Prosecution;

WHEREAS the Chamber has heard the Prosecution's response to the objections raised by the Praljak Defence;¹⁰

WHEREAS the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria specified in its Decision of 13 July 2006 on the admission of evidence;

WHEREAS the Chamber decides to admit into evidence documents indicated "admitted" in the Annex attached to this decision, since they were put to Witness CR and bear sufficient indicia of relevance, probative value, and reliability;

FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence ("Rules"); **GRANTS** the requests of the Petković Defence and Ćorić Defence:
