I, BAKONE JUSTICE MOLOTO, Judge of Trial Chamber I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

NOTING that at the Status Conference, held on 5 December 2006 (“Status Conference”), it was noted that the Accused Markač had submitted a request for clarification before the Appeals Chamber in relation to its decision of 25 October 2006 concerning potential conflicts of interest between various counsel in the present case and that pending that decision, no action by the Trial Chamber was required;


NOTING the Appeals Chamber’s “Decision on Appellant Mladen Markač’s Motion for Clarification” of 12 January 2007, wherein it remitted the submissions in the “Appellant Mladen Markač’s Motion for Clarification of the Appeals Chamber’s Decision from 25 October 2006” filed by Counsel for Markač on 8 November 2006 (“Motion”), relating to the question of whether Markač’s Counsel, Mr Miroslav Šeparović, will in fact be a necessary witness in his trial, to Trial Chamber 1 for further consideration;

PURSUANT TO Rules 54 and 65 *bis* (A),

HEREBY ORDER THAT

- (i) a status conference takes place on Friday 9 February 2007, at 1600 hours in Courtroom 1 to clarify the submissions made in the Motion by the Accused Markač and to discuss other related matters;
- (ii) the Accused Ante Gotovina, Ivan Čermak and Mladen Markač and their counsel to attend in person.
