TRIAL CHAMBER I ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

NOTING that by the "Decision on admission into evidence of site visit record", filed on 28 November 2006, the Trial Chamber, *inter alia*, admitted into evidence the record, consisting of five DVDs and the transcript thereof, of the site visit carried out in this case to locations in the Republic of Croatia between 25-30 September 2006, and ordered the Registrar to provide the Parties with copies of the five DVDs and the transcript thereof when finalised;

NOTING that at the hearing on 10 January 2007 the Defence stated that it had not received the DVDs prior to filing its final trial brief on 5 January 2007 and that it had not received the transcript of the DVDs before 10 January 2007;¹

NOTING that at the hearings on 10 and 12 January 2007 the Trial Chamber invited the Parties to make written submissions after having received the DVDs and the transcript thereof ("invitation");²

NOTING that the Trial Chamber informed the Parties via email on 8 January 2007 that the DVDs were ready for distribution by the Registry, and that the Registry has informed the Trial Chamber that the distribution occurred on or about 9 January 2007;

NOTING that on 22 January 2007 the Registry informed the Parties and the Trial Chamber via email that the transcript of the record had been finalised and uploaded into E-Court;

NOTING that neither Defence nor the Prosecution has made written submissions following the invitation;
