**I, FAUSTO POCAR**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“International Tribunal”),

**NOTING** the “Order Regarding Composition of Trial Chamber and Designating a Pre-Trial Judge” issued by Trial Chamber II on 23 November 2006;

**NOTING** that *ad litem* Judge Krister Thelin was appointed by the Secretary-General of the United Nations to the trial *Prosecutor v. Mrkšić et al.*, Case No. IT-95-13/1-T, in Trial Chamber II on which he presently sits;<sup>1</sup>

**NOTING** Security Council resolution 1481 (2003), which authorizes *ad litem* Judges to adjudicate in pre-trial proceedings in cases other than those they have been appointed to try;

**NOTING** that Judge Kevin Parker is temporarily absent from the International Tribunal;

**NOTING** that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal (“Rules”) authorizes the President of the International Tribunal to coordinate the work of the Chambers;

**CONSIDERING** the trial management and case distribution needs of the International Tribunal;


**HEREBY ASSIGN**, with immediate effect, Judge Krister Thelin to *Prosecutor v. Luboje Bošković and Johan Tarčulovski*, Case No. IT-04-82-PT, for the purposes of pre-trial work in this case in the absence of Judge Kevin Parker.
