1. With the consent of the Prosecution, the Ojdanić Defence tendered exhibits 3D557, 3D558, and 3D559 on 21 March 2007.¹

2. Pursuant to an oral decision issued by the Trial Chamber during the hearing on 21 March 2007, exhibit 3D557 was admitted but exhibits 3D558 and 3D559 were marked for identification, pending further order of the Chamber once an English translation became available.² The Ojdanić Defence was instructed to inform the Chamber and parties via a written filing once the translations became available and were uploaded to eCourt.

3. The Trial Chamber has been informed by the Ojdanić Defence that full and official translations for exhibits 3D558 and 3D559 have become available and have been uploaded to eCourt. The Ojdanić Defence now requests that the aforementioned exhibits be admitted into evidence.

4. Pursuant to Rules 54 and 89(C) of the Rules of Procedure and Evidence of the Tribunal, the Trial Chamber hereby ORDERS that the exhibits 3D558 and 3D559 (and their translations) shall be admitted into evidence.
