THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal") is seised of the "Prosecution's Submission Regarding the Testimony of US Rule 70 Witness Shaun Byrnes", filed on 24 April 2007 ("Motion"), and hereby renders its decision thereon.

- 1. Witness Shaun Byrnes, a United States Rule 70 witness, was added to the Prosecution's Rule 65 ter Witness List on 12 March 2007, following the Chamber's ruling that the Defence would not be unduly prejudiced by this course of action, despite some Rule 70 restrictions upon his testimony. In order to avert the possibility of undue prejudice, the Chamber decided to remain vigilant throughout the evidence of Mr. Byrnes and to review the situation after his evidence had been adduced. The Chamber had also issued a decision granting the Prosecution's motion, on behalf of the United States ("Rule 70 provider"), requesting non-disclosure and confidentiality of certain Rule 65 ter materials in connection with Mr. Byrnes.³
- 2. Mr. Byrnes gave evidence before this Trial Chamber on 16 and 17 April 2007. Only a small portion of that evidence was heard in private session in order to protect the material covered by the decisions on non-disclosure.⁴ Upon the completion of Mr. Byrnes' testimony, the Chamber instructed the Prosecution to advise it and the Defence, by 27 April 2007, which portions of the testimony, if any, should remain confidential.⁵
- 3. On 24 April 2007, the Chamber reviewed Mr. Byrnes' evidence and determined that its probative value was not outweighed by the need to ensure a fair trial. As a result, the Chamber issued a decision admitting the evidence.⁶
- 4. The present Motion has been filed in accordance with the Chamber's instructions relating to the evidence heard in private session. In the Motion, the Prosecution informs the Chamber that the Rule 70 provider has reviewed the transcript of Mr. Byrnes' evidence and has approved the confidential evidence, in its entirety, for public release. As a result, the Prosecution requests the
