RECALLING the Trial Chamber's "Order Postponing Start of Trial" of 19 April 2007 which postponed the commencement of trial indefinitely;

CONSIDERING that in the light of the postponed trial date, the Request and the delay in filing indicated in the Notice will not cause prejudice to the defence or to the administration of justice;

PURSUANT TO Rule 54 of the Rules,

HEREBY GRANTS the Request;

INVITES the Office of the Prosecutor to indicate when the Trial Chamber should expect the motions referred to in the Request and in the Notice.
