**NOTING** the "Order reassigning a case to a Trial Chamber and assigning Ad Litem Judges for pretrial work" by the President of the Tribunal, filed on 17 April 2007, assigning with immediate effect the case *Prosecutor v. Rasim Delić*, Case No. IT-04-83-PT, to Trial Chamber I;

**NOTING** the "Order regarding composition of Trial Chamber and designating a pre-trial Judge" by the Presiding Judge of Trial Chamber I, filed on 17 April 2007, ordering that Trial Chamber I, for the purposes of pre-trial proceedings, be composed of Judge Bakone Justice Moloto, Judge Krister Thelin, and Judge Janet Nosworthy, and designating Judge Bakone Justice Moloto as Pre-Trial Judge in this case, replacing Judge Krister Thelin;

**NOTING** that at the Status Conference on 21 May 2007 the matter of trial start was discussed and that the Parties proposed starting between 5 and 10 July 2007;

PURSUANT TO Rules 54 and 73 bis of the Rules of Procedure and Evidence ("Rules");

#### **ORDERS:**

- the Pre-Trial Conference pursuant to Rule 73 bis to take place on 2 July 2007;
- the Opening Statement of the Prosecution pursuant to Rule 84 to take place on 9 July 2007, followed by the Opening Statement of the Defence and/or a statement of the Accused pursuant to Rule 84 *bis*, if any at this stage of the proceedings, to conclude at the latest on 10 July 2007; and
- the presentation of evidence for the Prosecution to commence immediately after the Opening Statement of the Prosecution or, if applicable, Opening Statement of the Defence and/or a statement of the Accused pursuant to Rule 84 bis, but not later than on 11 July 2007.
