I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 ("International Tribunal"),

NOTING the Indictment in the *Prosecutor v. Zdravko Tolimir et al.*, Case No. IT-04-80-I, filed on 8 February 2005;

NOTING the "Order on Operative Indictment and Severance of Case Against Zdravko Tolimir", issued by Trial Chamber II on 15 August 2006 in which it ordered that Zdravko Tolimir be severed from Case No. IT-05-88-T, with immediate effect, and that the Registry assign a new case number to any further submission or proceedings that involve him;

NOTING the Indictment in the *Prosecutor v. Zdravko Tolimir*, Case No. IT-05-88/2-I, filed on 28 August 2006;

NOTING that the Registry has advised that Zdravko Tolimir ("Accused") has been detained and is expected to be transferred to the seat of the International Tribunal pursuant to Rule 62 of the Rules of Procedure and Evidence ("Rules");

NOTING that Rule 62 of the Rules requires the President of the International Tribunal forwith to assign the case to Trial Chamber upon the transfer of the Accused to the seat of the International Tribunal;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

CONSIDERING the composition of the Appeals Chamber of the International Tribunal as set out in document IT/245 issued on 12 May 2006;

HEREBY ASSIGN, effective on the date upon which the Accused is transferred to the seat of the International Tribunal, the present case to Trial Chamber II.
