

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal") *ex proprio motu* issues this Order concerning the English translation of exhibit P942.

1. On 25 October 2006, exhibit P942 (and its English translation) was admitted into evidence, during the testimony of Dušan Dunjić. This exhibit is a lengthy document, comprising forensic evidence, including autopsy reports, related to exhumations conducted at the site known as Batajnica II.
2. The Trial Chamber notes, however, that several pages of the English translation of P942 appear to be missing from the eCourt system, including pages of autopsy reports on victims identified as persons named in Schedule H of the Indictment.
3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby **ORDERS** that the Prosecution shall upload to eCourt by 2 July 2007, a complete English translation of P942, and inform the parties and the Chamber of such via a written filing, after which the newly-uploaded translation shall be deemed admitted into evidence and form part of the official record of these proceedings in lieu of the existing partial translation.
