I, Patrick Robinson, Presiding Judge of Trial Chamber III of the International Tribunal for the

Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law

Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

NOTING the Third Amended Joinder Indictment against Vlastimir Dorđević ("Accused"), which

was filed by the Office of the Prosecutor of the Tribunal on 6 July 2006, with the case number IT-

05-87/1-I;

NOTING the Order Assigning a Case to a Trial Chamber, issued by the Vice-President of the

Tribunal on 18 June 2007, assigning case number IT-05-87/1-I to this Trial Chamber;

NOTING the order dated 18 June 2007, by which the initial appearance of the Accused was to be

CONSIDERING the trial management and case distribution needs of the Trial Chamber;

Harhoff to Trial Chamber III for the purposes of pre-trial proceedings in the case of *Prosecutor v*.

Vlastimir Đorđević;²
