**BEING ASSIGNED** Pre-Trial Judge in the present case pursuant to Rule 65*ter* of the Rules of Procedure and Evidence ("Rules") by order of the Presiding Judge of Trial Chamber III dated 22 June 2007;<sup>1</sup>


**NOTING** that during his initial appearance held on 19 June 2007, the Accused did not enter a plea of guilty or not guilty;<sup>2</sup>

**NOTING** that therefore, pursuant to Rule 62(A)(iii) and (iv), a further initial appearance is to be convened within thirty days of the initial appearance, wherein the Accused will be called upon to enter a plea and that if he fails to do so, the Pre-Trial Judge shall enter a plea of not guilty on his behalf;

**PURSUANT TO** Rule 62(A) of the Rules of Procedure and Evidence of the Tribunal;

**HEREBY SCHEDULE** the further initial appearance of the Accused to be held on Monday 16 July 2007, at 9 a.m. in Courtroom III.
