I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the Former Yugoslavia since 1991 ("International Tribunal"),

NOTING the "Motion by the Prosecutor for Appointment of a Referral Bench Pursuant to Rule

11bis" filed on 5 July 2007, in which the Prosecutor requests that the President transfer this case to

a Referral Bench for purposes of referring this case to the authorities of Bosnia and Herzegovina for

trial;

NOTING that the Indictment against Rasim Delić was confirmed on 16 February 2005;

CONSIDERING that under Rule 11bis (A) of the Rules of Procedure and Evidence of the

International Tribunal, after an indictment against an accused has been confirmed and prior to the

commencement of trial, the President of the International Tribunal may appoint a bench of three

Permanent Judges selected from the Trial Chambers (hereinafter referred to as the "Referral

Bench") for the sole and exclusive purpose of determining whether a case should be referred to the

authorities of a State in whose territory the crime was committed, in which the accused was

arrested, or having jurisdiction and being willing and adequately prepared to accept such a case;

HEREBY APPOINT, effective immediately, the following Judges to constitute the Referral Bench

for the purpose of determining whether this case should be referred to the authorities of Bosnia and

Herzegovina pursuant to Rule 11bis of the Rules of Procedure and Evidence of the International

Tribunal:
