Mr. Djuro J. Čepić Mr. Jens Dieckmann **I, Krister Thelin**, Judge of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal"),

NOTING the Decision of the Referral Bench of 5 April 2007, referring the case of Milan Lukić and Sredoje Lukić to the authorities of Bosnia and Herzegovina ("Decision on Referral"),¹

NOTING the appeal of Milan Lukić against the Decision on Referral,²

CONSIDERING the Decision of the Appeals Chamber issued on 11 July 2007, granting the appeal of Milan Lukić and returning his case to the Trial Chamber ("Appeal Decision"),³

CONSIDERING that in light of the Appeal Decision, the Referral Bench revoked the Decision on Referral in relation to Sredoje Lukić who had not appealed the Referral Decision,⁴

NOTING the Trial Chamber held a Status Conference in this case on 11 June 2007,⁵ while the appeal of Milan Lukić was pending and before the Referral Bench issued its decision relating to the status of Sredoje Lukić,

NOTING Rule 65 *bis*(A) of the Rules of Procedure and Evidence ("Rules"), which states that a "Trial Chamber or a Trial Chamber Judge shall convene a status conference within one hundred and twenty days of the initial appearance of the accused and thereafter within one hundred and twenty days after the last status conference",

PURSUANT to Rules 54 and 65 bis of the Rules,

HEREBY SCHEDULE a Status Conference for Tuesday, 4 September 2007, commencing at 3:00 p.m. in Courtroom 2.
