ORDER TO ADMIT EVIDENCE REGARDING WITNESS DD

TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

CONSIDERING that at the hearing of 22 February 2007, the Office of the Prosecutor ("Prosecution") moved for the admission of 17 documents, and that Counsel for the Accused Prlić ("Prlić Defence"), Counsel for the Accused Stojić ("Stojić Defence") and Counsel for the Accused Ćorić ("Ćorić Defence") moved respectively for the admission of 5, 3 and 7 documents relating to the testimony of DD ("Proposed Exhibits"), who appeared before the Chamber on 20 and 21 February 2007,

CONSIDERING that the Chamber has heard the objections of the Stojić Defence ("Stojić Defence Objection")⁶ and the Ćorić Defence⁷ to the admission of the evidence proposed by the Prosecution,

CONSIDERING that the Chamber has heard the Prosecution's response to the Stojić Defence Objections ("Prosecution Response"),⁸

CONSIDERING that the Chamber notes nonetheless that the Stojić Defence Objection and the Prosecution Response were not filed during the hearing as IC lists and recalls, in this regard, the Parties' obligation to abide by the procedure set out in the Decision on Admission into the Record of Documents Presented at the Hearing rendered on 13 December 2006.

CONSIDERING that the Chamber has examined each of the Proposed Exhibits based on the criteria for admissibility defined in the Decision of 13 July 2006 on the admission of evidence,

CONSIDERING that the Chamber finds that document 1D 01117 is important in the context of Witness DD's testimony since it deals with the rights of refugees from the municipality of Čapljina in 1992 and, by reason of its normative and public nature, also contains intrinsic elements of reliability,

CONSIDERING consequently that the Chamber decides exceptionally to admit document 1D 01117 even though it was given no comment by Witness DD at the hearing,

CONSIDERING that the Chamber hereby decides to admit into evidence the documents labelled "admitted" in the Annex attached to this decision because they were submitted to Witness DD and have satisfactory indicia of relevance, probative value and reliability,

CONSIDERING that the Chamber decides not to admit into evidence the Proposed Exhibits marked "not admitted" in the Annex attached to this Decision since they are not in compliance with the Decision of 13 July 2006,

FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence.

GRANTS the motions of the Prlić Defence, Stojić Defence and Ćorić Defence,

PARTIALLY GRANTS the motion of the Prosecution,

ADMITS into evidence the documents labelled "admitted" in the Annex attached to this decision,

AND

DENIES the Prosecution's motion in all other respects.
