Persons Responsible for Serious Violations of International Humanitarian Law Committed in the

Territory of the Former Yugoslavia Since 1991 ("International Tribunal"),

NOTING the "Decision on the Prosecutor's Request for Deferral and Motion for Order to the

Former Yugoslav Republic of Macedonia" issued by Trial Chamber I on 4 October 2002, which

formally requested the Macedonian government to defer to the competence of the Tribunal with

respect to five specific cases and investigations;
