**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**NOTING** that, pursuant to Article 20(1) of the Statute, the Trial Chamber shall ensure that this trial is conducted in a fair and expeditious manner, in accordance with the Rules of Procedure and Evidence (“Rules”), with full respect for the rights of each Accused and due regard for the protection of victims and witnesses;

**NOTING** the “Prosecution’s Filing of Pre-Trial Brief Pursuant to Rule 65 *ter* and List of Exhibits Pursuant to Rule 65 *ter*(E)(v)”, filed under seal on 28 April 2006 (“Pre-Trial Brief”), which contains as Confidential Annex C the Prosecution 65 *ter* Exhibit List (“initial Exhibit List”);

**NOTING** that the Prosecution has been granted leave to revise the initial Exhibit List on several occasions during the course of the trial;

**CONSIDERING** that it would assist the Trial Chamber and the parties during the presentation of the remainder of the evidence for the Prosecution, if the Prosecution submitted a revised version of the initial Exhibit List incorporating all the revisions that have been made to it;

**NOTING** the “Order Concerning Guidelines on the Presentation of Evidence and the Conduct of the Parties During Trial Proceedings”, issued on 14 July 2006;

**NOTING** that the Prosecution case will soon be completed;<sup>1</sup>

**CONSIDERING** that in order to plan the phase of the proceedings between the close of the Prosecution case and the commencement of the Defence case, and in particular the proceedings required under Rule 98 *bis*, it is necessary for the Trial Chamber to have as accurate as possible an estimate of the length of the remainder of the Prosecution case;

**PURSUANT TO** Article 20(1) of the Statute and Rules 54 and 65 *ter*,

**HEREBY ORDERS** the Prosecution to take the following actions by 15 October 2007:


1. To provide the Trial Chamber and the Accused with a revised version of the initial Exhibit List incorporating all the revisions that have been made to it thus far during the trial; and

2. To provide the Trial Chamber and the Accused, as far as possible, with a list of all witnesses the Prosecution expects to call during the remainder of the Prosecution case, stating an estimated total time to be taken for examination-in-chief of each witness, the date or dates on which the Prosecution currently anticipates that the witness will give his or her testimony, and the exhibits the Prosecution intends to use with the witness.
