SUSPENDING PROVISIONAL RELEASE**

**TRIAL CHAMBER I** (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**CONSIDERING** Rule 65 *bis*(A) of the Rules of Procedure and Evidence (“Rules”) according to which a status conference shall be convened within one hundred and twenty days after the last status conference;

**CONSIDERING** that the last status conference was held on 6 July 2007;

**CONSIDERING** that the Accused Čermak and the Accused Markač are on provisional release in the Republic of Croatia (“Croatia”) pursuant to Rule 65 of the Rules and that according to the conditions applicable to their provisional release they shall “return to the custody of the International Tribunal at such time and on such date as the Trial Chamber may order” and “comply strictly with any order by the Trial Chamber varying the terms of, or terminating, the provisional release”;<sup>1</sup>

**PURSUANT TO** Article 29 of the Statute of the Tribunal and Rules 65 and 65 *bis*(A);

**ORDERS** that a status conference take place on Friday 26 October 2007, starting at 1415 hours, in Courtroom 3;

**ORDERS** that the Accused Ivan Čermak and Mladen Markač return to the United Nations Detention Unit in order to attend the status conference and therefore **SUSPENDS** their provisional release;

**ORDERS** the Government of Croatia to ensure that each Accused is transported, under guard, from the municipality of Zagreb, Croatia, to Schiphol Airport or any other airport in the Netherlands and released into the custody of designated officials of the Government of the Kingdom of the Netherlands (“Netherlands”);

**ORDERS** the Government of the Netherlands to ensure that each Accused is transported, under guard, from Schiphol Airport or any other airport in the Netherlands to the United Nations Detention Unit;



**ORDERS** the Government of Croatia, the Government of the Netherlands and the Registry of the Tribunal to communicate with each other to facilitate the orderly and timely return of each Accused to the United Nations Detention Unit;

**ORDERS** that the suspension of the provisional release shall remain in effect until modified by the Trial Chamber.
