**TRIAL CHAMBER III** (“Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**CONSIDERING** that the Office of the Prosecutor (“Prosecution”) requested the admission of 30 pieces of evidence<sup>1</sup> while Counsel for the Accused Stojić (“Stojić Defence”), Counsel for the Accused Petković (“Petković Defence”), Counsel for the Accused Praljak (“Praljak Defence”) and Counsel for the Accused Ćorić (“Ćorić Defence”) requested the admission of 1,<sup>2</sup> 4,<sup>3</sup> 22<sup>4</sup> and 10<sup>5</sup> pieces of evidence, respectively, related to the testimony of Witness C (“Proposed Exhibits”) who appeared before the Chamber on 17, 18 and 19 September 2007,

**CONSIDERING** that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in its Decision of 13 July 2006 on the admission of evidence (“Decision of 13 July 2006”);

**CONSIDERING** that the Chamber notes that Exhibits P 03057, P 03075, P 03119, P 03129, P 03161, P 03201, P 3326, P 03328, P 03347, P 03377, P 03446, P 03462, P 03794, P 05647, 4D 00461 and 5D 02056 have already been admitted and that, consequently, the requests in respect thereof are moot,

**CONSIDERING** that the Chamber decides to admit into evidence the documents indicated “Admitted” in the Annex attached to this decision since they were put to Witness C and bear sufficient indicia of relevance, probative value, and reliability;

**CONSIDERING** that the Chamber decides not to admit into evidence the Proposed Exhibits indicated “Not Admitted” in the Annex attached to this decision since they do not satisfy the requirements of the Decision of 13 July 2006,

**PURSUANT TO** Rules 54 and 89 of the Rules of Procedure and Evidence;

**GRANTS** the requests for admission of the Stojić Defence and the Praljak Defence,

**PARTIALLY GRANTS** the requests for admission of the Prosecution, the Petković Defence and Ćorić Defence,

**DECIDES TO ADMIT** into evidence the documents indicated “Admitted” in the Annex attached to this decision.

**DENIES** in all the other respects the requests for admission of the Prosecution, the Petković Defence and Ćorić Defence for the reasons stated in the Annex.
