THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal") is seised of "Sreten Lukić's Notice with Respect to Translations of Document Tendered Through the Witness Qamil Shabani and the Request for Admiting [*sic*] This into Evidence," filed on 26 September 2007 ("Motion"), requesting the admission of exhibit 6D69 together with its translation, and hereby issues this order thereon.

1. On 1 September 2006, exhibit 6D69, namely "Criminal Brief," was marked for identification in eCourt, pending translation.¹ In the Motion, the Lukić Defence informs the parties and the Chamber that it has provided the Registry with the official translation of exhibit 6D69. Further, the Defence requests that the exhibit and its translation be admitted into evidence. The Chamber notes that the exhibit and its translation are indeed available in eCourt.

2. The Prosecution did not respond to the Motion.

3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS that exhibit 6D69 and its translation shall be admitted into evidence.
