

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of the “Sixth General Dragoljub Ojdanic’s Motion to Add Exhibit,” filed 19 October 2007 (“Motion”), and hereby issues this decision thereon.

1. In the Motion, the Ojdanić Defence seeks to add exhibit 3D1122, entitled “Law on state crossing border,” to its Rule 65 *ter* exhibit list¹ on the basis that the Trial Chamber requested the Defence to add the afore-mentioned document as an exhibit. The Defence argues that exhibit 3D1122 is relevant and necessary to the Ojdanić defence case and that its addition to the list would serve the interests of justice.
2. The Prosecution has indicated that it does not intend to oppose the Motion.
3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 65 *ter* of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion.
