**ORDER TO ADMIT EVIDENCE REGARDING WITNESS DV**

**TRIAL CHAMBER III** (“Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”),

**CONSIDERING** that the Office of the Prosecutor (“Prosecution”) requested the admission of 29 exhibits<sup>1</sup> while Counsel for the Accused Petković (“Petković Defence”), Counsel for the Accused Stojić (“Stojić Defence”), and Counsel for the Accused Praljak (“Praljak Defence”) requested the admission of 2,<sup>2</sup> 7<sup>3</sup> and 23<sup>4</sup> exhibits, respectively, related to the testimony of Witness DV (“Proposed Exhibits”) who appeared before the Chamber on 1 and 2 October 2007,

**CONSIDERING** that the Parties have formulated no objections to the admission of the Proposed Exhibits,

**CONSIDERING** that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in its Decision of 13 July 2006 on the admission of evidence (“Decision of 13 July 2006”),

**CONSIDERING** that the Chamber notes that Exhibits P 02723, P 03545, P 03547, P 04870, P 04623, P 04905, P 02547, 3D 01001, 3D 01006, 3D 01007, 3D01008, 3D 01009 and 3D 01023 have already been admitted and that, consequently, there is no reason to rule on their admission again,

**CONSIDERING** that the Chamber decides to admit into evidence the documents indicated “Admitted” in the Annex attached to this decision since they were put to Witness DV and bear sufficient indicia of relevance, probative value and reliability,

**CONSIDERING** that the Chamber decides not to admit into evidence the Proposed Exhibits indicated “Not Admitted” in the Annex attached to this decision since they are not consistent with the instructions of the Decision of 13 July 2006,

**FOR THE FOREGOING REASONS,**

**PURSUANT TO** Rules 54 and 89 of the Rules of Procedure and Evidence,

**PARTIALLY GRANTS**, by majority, the requests of the Prosecution, the Stojić Defence, and the Praljak Defence,

**GRANTS** unanimously the request of the Petković Defence,

**DECIDES** unanimously that the documents indicated “Admitted” in the Annex attached to this Decision should be admitted into evidence,

**DENIES** in all the other respects the requests of the Prosecution, the Stojić Defence and the Praljak Defence for the reasons stated in the Annex attached to this Decision.
