I INTRODUCTION

1. Trial Chamber III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal") is seized of two motions: 1) "Prosecution Motion for Admission of Documentary Evidence", filed by the Office of the Prosecution ("Prosecution") on 28 June 2007 ("Motion 1") modified by the "Amended Prosecution Motion for Admission of Documentary Evidence" filed on 27 August 2007, ("Amended Motion 1") and 2) partly confidential "Prosecution Motion for Admission of Documentary Evidence" filed on 21 September 2007 ("Motion 2"), in which the Prosecution requests the admission into evidence of 398 documents (Motion 1 and Amended Motion 1) and of 539 documents (Motion 2) relating to the administrative, military and political operations, processes and structures of the HVO or of Herceg-Bosna ("Proposed Exhibits"), pursuant to Rule 89 (C) of the Rules of Procedure and Evidence ("Rules").

II PROCEDURAL BACKGROUND

A - Motion 1:

2. On 8 August 2007, the Chamber rendered a Decision¹ ("Decision of 8 August 2007"), in which it dismissed Motion 1 on the ground that it does not contain information required in item a) iv) of Guideline 6 as amended in the "Decision Amending the Decision on the Admission of Evidence Dated 13 July 2006" ("Guideline 6"), rendered on 29 November 2006 ("Decision of 29 November 2006"). The Chamber also invited the Prosecution to resubmit the Proposed Exhibits in accordance with Guideline 6.

3. On 27 August 2007, in line with the instructions in the Decision of 8 August 2007, the Prosecution filed Amended Motion 1, in which it resubmitted Motion 1 in accordance with item a) iv) of Guideline 6. It submitted an Annex, in which it mentions evidence already tendered into the file relating to the same paragraphs in the Indictment amended on 16 November 2005 ("Indictment") as the Proposed Exhibits.

4. In its oral Decision of 3 August 2007, the Chamber granted the Defence an extension of time until 8 October 2007 to file its response.² On 8 October 2007, the Counsel for the six Accused ("Defence") filed a confidential "Joint Defence Response to Prosecution Motion for Admission of Documentary Evidence" ("Joint Response 1"), with an attached Annex ("Annex to Joint Response 1"), in which the Defence objects both jointly and individually to the request

to admit the Proposed Exhibits.

5. In its oral Decision of 16 October 2007, 3 the Chamber authorised the Prosecution to file a reply to Joint Response 1. On 22 October 2007, the Prosecution filed "Prosecution Reply to Joint Defence Response to Prosecution Motion for Admission of Documentary Evidence"

("Reply 1"), in which it replied to arguments raised by the Defence in Joint Response 1.

6. On 30 October 2007, the Counsel for the Accused Ćorić ("Ćorić Defence") filed "Ćorić's Request for Leave to Reply to Prosecution Reply to Joint Response to Prosecution Motion for the Admission of Documentary Evidence" ("Request for Leave to Reply") asking for leave to file a rejoinder to Reply 1 on the ground that in Reply 1 the Prosecution allegedly interpreted the Defence's remarks incorrectly. On 31 October 2007, the Prosecution filed a "Corrigendum to Prosecution Reply to Joint Defence Response to Prosecution Motion for Admission of Documentary Evidence" ("Corrigendum"), in which it amended Reply 1 and corrected its interpretation of the Defence's remarks.

B - Motion 2:

7. On 19 October 2007, Counsel for the Accused Stojić, Praljak, Petković, Ćorić and Pušić filed a confidential "Joint Response by 5 Accused Bruno Stojić, Slobodan Praljak, Milivoj Petković, Valentin Ćorić, and Berislav Pušić to Prosecution Motion Filed 20 September 2007 for Admission of Documentary Evidence (539 Items Exhibits Related to Herceg-Bosna/HVO Political, Military and Administrative Structures, etc.)" ("Joint Response 2"), in which it primarily requests the dismissal of Motion 2 or, alternatively, that the Chamber dismiss the said Motion and request the Prosecution to re-submit a justifiable motion, limited to 300

items. Joint Response 2 has six annexes ("Annexes to Joint Response 2").

8. On 19 October 2007, the Counsel for the Accused Prlić ("Prlić Defence") filed "Jadranko Prlic's Response to Prosecution Motion for Admission of Documentary Evidence Dated 20

September 2007" (Prlić's Response to Motion 2"), in which they object to the request to admit the Proposed Exhibits through Motion 2.

9. On 25 October 2007, the Prosecution filed a "Prosecution Request for Leave to Reply to Defence Responses to Prosecution's 20 September 2007 Motion for Admission of Documentary Evidence". On 31 October 2007, the Chamber sent an electronic message informing the Parties of its intention to grant this request. On 7 November 2007, the Prosecution filed a confidential "Consolidated Prosecution Reply to Joint Response by Five Accused and Separate Prlić Response to Prosecution Motion Filed 20 September 2007 for Admission of Documentary Evidence" ("Reply 2"), in which it responded to the objections raised by the various Defence teams.

III ARGUMENTS OF THE PARTIES

10. In support of Motion 1, Amended Motion 1 and Motion 2 ("Request") the Prosecution submits that the Request fulfils the criteria for admission of documentary evidence set out by the Chamber⁴ and that the Proposed Exhibits are relevant, reliable and have probative value with regard to facts alleged in the Indictment, particularly with regard to the administrative, military and political operations, processes and structure of the HVO and Herceg-Bosna.⁵

11. Through its Request, the Prosecution moreover specified that owing to the imposed time restrictions in this case, it does not intend to call *viva voce* witnesses in order to present the Proposed Exhibit.⁶ Finally, it argues that, while taking into account the nature and scope of the case, it has taken care to make a selection of the Proposed Exhibits.⁷

12. In Joint Response 1, Joint Response 2 and Prlic's Response to Motion 2 ("Response"), the Defence objects generally to the admission of the Proposed Exhibits. The Chamber notes that each Defence team presents individual objections to the Proposed Exhibits. 8

13. In its Response, the Defence objects to the Request by arguing that the Prosecution disregards the jurisprudence of the Tribunal and the Chamber's Guidelines on the admission of evidence.⁹

14. In its Response, the Defence also argues the importance of presenting the Proposed Exhibits in court inter partes 10 and holds that the Prosecution has not provided valid justification for these documents not to be presented through witnesses who could be called to testify before the Chamber. 11 The Defence also attacks a number of documents by contesting their reliability and relevance due to the absence of sufficient evidence of their authenticity and to the interpretation provided by the Prosecution.¹²

15. Moreover, the Defence points out the large number of Proposed Exhibits in the Reugest and challenges the lack of selection. 13 With regard to Motion 2, it requests the Chamber to limit the request for admission to 300 documents and not the 539 Proposed Exhibits.¹⁴

16. More specifically, the Defence holds that the Request is not presented in a consistent manner. 15 It identifies Prosecution errors, maintaining that documents have already been admitted or are pending admission; ¹⁶ that some are duplicates of documents already admitted or of those that have already been tendered for admission in the Request; that some are illegible 17 or that some of the translations are missing or even incorrect. 18

17. Finally, the Prlić Defence argues the limited time available at the hearing to refute evidence through cross-examination and maintains that it should be allowed to request the admission of evidence in writing during the Prosecution case-in-chief. 19

18. In Reply 1, in its Corrigendum and in Reply 2 ("Reply"), the Prosecution claims that it complied with the practice of the Chamber regarding the admission of evidence and responds to the Defence's arguments regarding the reliability and relevance of the Proposed Exhibits.²⁰ It reminds the Defence of the decisions rendered by the Chamber on this subject and that, as a result, the general objections by the Defence are without foundation.²¹

19. In its Reply, the Prosecution refers in particular to the conclusions by the *Hadžihasanović* Chamber on the admission of evidence, in which the admission criteria do not necessarily

need to be cumulative or too narrow and that the final decision on the probative value of an exhibit is only taken at the end of the trial when evaluating all the evidence.²²

- 20. Moreover, the Prosecution maintains that the Defence is mistaken when it claims that the Proposed Exhibits were not subjected to a rigorous selection and that some witnesses could appear to testify about these documents.²³ It challenges in part the Defence's assertion that the Request contains errors by maintaining that that the majority of the Proposed Exhibits are in fact similar and not identical to other documents.²⁴ Nevertheless, it agrees to withdraw from the Request a number of Proposed Exhibits.²⁵
- 21. Furthermore, the Prosecution claims that it has the right to request the admission of the same document several times, until the Chamber rules on the matter.²⁶
- 22. Finally, the Prosecution responds to the Prlić Defence that it is not presenting any new argument to the Chamber, other than refusing to accept that the Tribunal does not rely solely on an adversarial system.²⁷

IV. DISCUSSION

- 23. First of all, the Chamber considers that in its Corrigendum the Prosecution has amended Reply 1 as requested by the Ćorić Defence and in its Request for Leave to Reply. Therefore, the Chamber considers that this request has become moot.
- 24. In the interest of clarity, the Chamber decides to deal in this Decision with the Parties' arguments only as a whole, without discussing all the objections raised. It decides to deal with every Proposed Exhibit in Annexes 1 and 2 attached to this Decision, precisely indicating the grounds for dismissal and the grounds on which the Chamber pronounces the Request moot. The Chamber notes that it has taken due consideration of the assertions made in support of the Request, the Response and the Reply and that considering their large number, it will not discuss them in this Decision.

25. With regard to the Parties' arguments, the Chamber must recall once again earlier

decisions in which it stipulated the principles of admissibility of evidence, notably the

"Decision on Admission of Evidence" of 13 July 2006, the Decision of 29 November 2006

and the "Decision on Admission of Documentary Evidence Relating to Prozor Municipality"

of 20 February 2007, as well as the "Decision on Jadranko Prlić's Request for Reconsideration

of the Decision of 29 November 2006" of 30 August 2007.

26. The Chamber notes with regard to the Request and the Reply that the Prosecution has

reduced the number of Proposed Exhibits and requests the final admission of 391 Proposed

Exhibits in Motion 1 and 484 Proposed Exhibits in Motion 2.

27. The Chamber also notes that in the Annexes attached to the Request, the Prosecution has

provided the information required by Guideline 6.

28. The Chamber, however, finds that, despite the corrections made to the Request through the

Reply, some Proposed Exhibits have already been admitted or are pending admission as they

were presented through a witness at the hearing; that the English translation of some exhibits

is missing from the E-court system or is incorrect; that some of the original copies of

documents are illegible and that others are identical to documents that have already been

admitted or whose admission was already requested in the Request. The Chamber therefore

decides, as specified in Annexes 1 and 3 attached to this Decision, that the Request is either

dismissed or moot in their regard.

29. Moreover, the Chamber agrees in part with the Defence that the Prosecution could have

selected the Proposed Exhibits more carefully by avoiding the submission of duplicates, by

specifying the relevant pages of some large documents and, particularly, by improving their

organisational methods in order to avoid requesting the admission of Proposed Exhibits both

through the Request and in other requests for admission through several witnesses who came

to testify at the hearing. The Chamber notes with regret the organisation of the Proposed

Exhibits, which were presented under the title "administrative, military and political

operations, processes and structures of the HVO or Herceg-Bosna". The Chamber holds that

the Prosecution could have and should have made a more rigorous selection of the Proposed

Exhibits, since many documents relate to events that occurred in municipalities or in detention

camps, to the presence of HV troops, the responsibility of one or several of the Accused or to

the international armed conflict. Despite the lack of coherence in the selection of the Proposed

Exhibits, given the advanced stage of the proceedings, the Chamber decides exceptionally to deal with the entire Request.

30. With regard to the consideration of the merits, after having heard the objections of the Defence, in particular those relating to the interpretation and the weight to be attached to the Proposed Exhibits, the Chamber must remind the Defence once more that at this stage of the proceedings, it only evaluates the admissibility of exhibits requested for admission and does not need to provide a final evaluation of their probative value. It will only do this at the end of the trial after all the Prosecution and Defence evidence has been tendered into the case file. When making this evaluation, the Chamber will take into account that there might be a discrepancy between exhibits; that the Defence challenges the Prosecution's interpretation or the exhibits' authenticity; that some information represents hear-say; and that the Defence has not had the opportunity to test the Proposed Exhibits through cross-examination or during the presentation of the Defence case.

31. Moreover, the Chamber must again remind the Defence, and the Prlić Defence in particular, that the way evidence is presented before this international jurisdiction is specific and autonomous, in that it is not governed by the Common Law system, but is as much inspired by it as by civil law. Therefore, the Chamber recalls the Tribunal's jurisprudence in which the right to cross-examination is not unlimited and a Chamber may admit evidence without cross-examination, even when it goes to the acts and conduct of an Accused. Moreover, the Chamber considers that the Defence could, if it wished, challenge the Proposed Exhibits through its own witnesses during the presentation of the Defence case.

32. In view of the information provided by the Prosecution in the Request and in the Reply and the objections raised by the Defence to each Proposed Exhibit, the Chamber decides to admit the Proposed Exhibits listed as admitted in Annexes 1 and 2 attached to this Decision, since they have sufficient indicia of reliability, relevance and probative value with regard to the administrative, military and political operations, processes and structures of the HVO and Herceg-Bosna or to the Indictment in general and that they should, therefore, be admitted.

33. Finally, the Chamber dismisses the Proposed Exhibits marked "Not admitted" in Annexes 1 and 2 attached to this Decision, since they do not have sufficient indicia of reliability,

relevance or probative value, or because they will be dealt with in other decisions relating to the requests for the admission of evidence presented at the hearing through witnesses.

FOR THE FOREGOING REASONS,

PURSUANT to Rule 89 (C) of the Rules,

GRANTS the Prosecution's request to reply to Joint Response 2 and to Prlic's Response to Motion 2,

DECLARES the Request for Leave to Reply moot,

PARTIALLY GRANTS the Request,

DECIDES that there is reason to admit to the case file the evidence marked "Admitted" in Annexes 1 and 2 attached to this Decision,

DECLARES the Request **MOOT** for Proposed Exhibits marked "MOOT" for reasons given in Annex 1 and 2 attached to this Decision,

DEFERS its ruling on Exhibit P 02280 on the grounds given in Annex 1 attached to this Decision, **AND**

DENIES in all other respects the Prosecution Request on the grounds given in Annexes 1 and 2 attached to this Decision.
