**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of the “Ojdanic Motion to Replace Documents in eCourt with Annexes (3D827; 3D833; 3D834; 3D845; 3D851),” filed publicly on 29 November 2007, and “Ojdanic Motion to Replace Documents in eCourt with Annexes (3D601; 3D602; 3D604; 3D605; 3D607; 3D608; 3D609; 3D610; 3D611; 3D612; 3D614; 3D626; 3D630; 3D606),” filed publicly on 29 November 2007 (collectively “Motions”), and hereby issues this order thereon.

1. In its Motions, the Ojdanić Defence asserts that, after a review of the 3D Defence folder in the eCourt system, several defects were identified with respect to the documents addressed in the Motions.<sup>1</sup> Specifically, documents 3D601; 3D602; 3D604; 3D605; 3D608; 3D609; 3D610; 3D611; 3D612; 3D614; 3D626; 3D630; 3D827; 3D833; 3D834; 3D845; 3D851, which were previously denied admission from the bar table, are missing either one or more pages each.<sup>2</sup> In addition, 3D606, which was admitted into evidence on 7 September 2007, and 3D607, which is yet to be tendered by either the Prosecution or Defence, are missing one page each.<sup>3</sup> The Ojdanić Defence seeks leave to replace these documents with corrected versions.

2. Prosecution has indicated that it does not intend to oppose the Motions.

3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motions and ORDERS as follows:


- a. The Ojdanić Defence is granted leave to replace the corrected versions of 3D601; 3D602; 3D604; 3D605; 3D606; 3D607; 3D608; 3D609; 3D610; 3D611; 3D612; 3D614; 3D626; 3D630; 3D827; 3D833; 3D834; 3D845; 3D851 for the previous versions in eCourt.
- b. The corrected version of exhibit 3D606 and its translation shall be admitted into evidence.
