**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

**CONSIDERING** that the Office of the Prosecutor ("Prosecution") requested the admission of 32 exhibits<sup>1</sup> while Counsel for the Accused Stojić ("Stojić Defence"), Counsel for the Accused Praljak ("Praljak Defence"), Counsel for the Accused Corić ("Ćorić Defence") and Counsel for the Accused Pušić ("Pušić Defence") requested the admission of  $10^2$ ,  $10^3$ ,  $2^4$  and  $6^5$  exhibits, respectively, related to the testimony of Witness Antoon Van der Grinten ("Proposed Exhibits") who appeared before the Chamber on 10 and 11 July 2007,

**CONSIDERING** that the Chamber has examined the objections formulated by the Prosecution to the admission of the Proposed Exhibits,<sup>6</sup>

**CONSIDERING** that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in its Decision of 13 July 2006 on the admission of evidence ("Decision of 13 July 2006"),

**CONSIDERING** that the Chamber notes that Exhibits P 03900, 2D 00322, 3D 00844 (page 3D23-0229) P 02985, P 09214, P 09218 and P 09232 have already been admitted and that there is no reason to rule on their admission again,

**CONSIDERING** that the Chamber decides to admit into evidence the Proposed Exhibits indicated "Admitted" in the Annex attached to this decision since they were put to Witness Antoon Van der Grinten and bear sufficient indicia of relevance, probative value and reliability,

**CONSIDERING** that the Chamber decides not to admit into evidence the Proposed Exhibits indicated "Not Admitted" in the Annex attached to this decision since they are not consistent with the instructions of the Decision of 13 July 2006,

**DENIES** in all the other respects the requests of the Prosecution, the Stojić Defence, the Praljak Defence, the Ćorić Defence and the Pušić Defence for the reasons stated in the Annex attached to this Decision.
