TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

CONSIDERING that the Office of the Prosecutor ("Prosecution") requested the admission of 32 exhibits¹ while Counsel for the Accused Prlić ("Prlić Defence") and Counsel for the Accused Stojić ("Stojić Defence") requested the admission of 31² and 9³ exhibits, respectively, related to the testimony of Witness Miroslav Rupčić ("Proposed Exhibits") who appeared before the Chamber on 8, 9 and 10 October 2007,

NOTING the "Decision on Admission of Evidence" rendered by the Chamber on 13 July 2006 ("Decision of 13 July 2006"),

CONSIDERING that the Chamber has heard the objections formulated by the Prosecution with regard to the admission of exhibits 1D 00213, 1D 00218, 1D 00297, 1D 00307, 1D 00308, 1D 01753, 1D 01754, 1D 01757, 1D 01758, 1D 01759, 1D 01760, 1D 01761, 1D 01762, 1D 01763, 1D 01769, 1D 01770, 1D 01771, 1D 01772 and 1D 01774 requested for admission by the Prlić Defence,⁴

CONSIDERING that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in the Decision of 13 July 2006, while bearing in mind the Prosecution's objections,

CONSIDERING that the Chamber decides to admit into evidence the Proposed Exhibits indicated "Admitted" in the Annex attached to this Decision since they were put to Witness Miroslav Rupčić and bear sufficient indicia of relevance, probative value and reliability,

CONSIDERING that the Chamber decides not to admit into evidence the Proposed Exhibits indicated "Not Admitted" in the Annex attached to this Decision since they are not consistent with the instructions of the Decision of 13 July 2006,

FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence,

PARTIALLY GRANTS the requests of the Prosecution, the Prlić Defence and the Stojić Defence,

DECIDES that the Proposed Exhibits indicated "Admitted" in the Annex attached to this Decision should be admitted into evidence,

DECIDES to deny exhibits 1D 00308 and 2D 00532 for the reasons set out in the Annex to this Decision,

DECLARES the request to admit exhibits P 00332, P 00511, P 10267 and P 10284 moot since they were previously admitted by the Chamber **AND**

DECIDES by a majority of the Chamber's Judges to deny in all the other respects the requests of the Prosecution and the Prlić Defence for the reasons stated in the Annex attached to this Decision.
