TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

CONSIDERING that the Office of the Prosecutor ("Prosecution") requested the admission of 38 exhibits¹ while Counsel for the Accused Prlić ("Prlić Defence"), Counsel for the Accused Stojić ("Stojić Defence"), Counsel for the Accused Praljak ("Praljak Defence"), Counsel for the Accused Ćorić ("Ćorić Defence") and Counsel for the Accused Pušić ("Pušić Defence") respectively requested the admission 29,² 1,³ 2,⁴ 8⁵ and 5⁶ exhibits related to the testimony of Witness BB ("Proposed Exhibits") who appeared from 16 to 18 April 2007 and on 28 and 29 November 2007,

CONSIDERING that the Petković Defence did not file a request for the admission of evidence,

CONSIDERING that the Chamber has examined the objections and the responses to the objections raised by the Parties to the admission of the Proposed Exhibits,⁷

CONSIDERING that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in its Decision of 13 July 2006 on the admission of evidence ("Decision of 13 July 2006"),

CONSIDERING that the Chamber notes that among the exhibits the Prosecution requests for admission, twenty have already been admitted by the Chamber and that as a result it need not rule again on their admission, as indicated in the Annex attached to this decision,

CONSIDERING that the Chamber notes that Witness BB was unable to provide the Chamber with information on the relevance, probative value or reliability of the exhibits presented in particular by the Prlić Defence,

CONSIDERING that the Chamber holds that Exhibit 1D 00730 is relevant since it deals with the issue of apartments abandoned in Mostar during the period covered by the testimony of

Witness BB and that because of its normative and public nature, it contains intrinsic elements of reliability,

CONSIDERING as a result that the Chamber decides, exceptionally, to admit Exhibit 1D 00730,

CONSIDERING that the Chamber decides to admit into evidence the Proposed Exhibits indicated "Admitted" in the Annex attached to this decision since they were put to Witness BB and bear sufficient indicia of relevance, probative value and reliability,

CONSIDERING that the Chamber decides not to admit into evidence the Proposed Exhibits indicated "Not admitted" in the Annex attached to this decision since they fail to comply with the instructions of the Decision of 13 July 2006,

FOR THESE REASONS,

PURSUANT TO Rules 54 and 89 of the Rules,

DISMISSES as most the request for admission of Exhibits previously admitted by the Chamber, as indicated in the Annex attached to this decision,

GRANTS the requests for admission of the Stojić Defence and Praljak Defence,

PARTIALLY GRANTS the requests for admission of the Prosecution, Prlić Defence, Ćorić Defence and Pušić Defence,

DECIDES that there is cause to admit the Proposed Exhibits indicated "Admitted" in the Annex attached to this decision,

DENIES by a majority of the Judges of the Chamber, the request for admission of the Prlić Defence concerning Exhibits 1D 00606, 1D 00641 and 1D 00717 for the reasons explained in the Annex attached to this decision,

AND,

DENIES in all other respects the requests of the Prosecution, Prlić Defence, Ćorić Defence Pušić Defence for the reasons explained in the Annex attached to this decision,
