THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal") is seised of the motion entitled, "Lazarević Defence Notice Regarding MFI Documents", filed on 18 January 2008 ("Motion"), and hereby renders this Order thereon.

- 1. In its Motion, the Lazarević Defence notifies the Chamber that outstanding translations of 5D199, 5D208, 5D215, 5D319, 5D666, 5D670, 5D675, 5D687, 5D690, 5D910, 5D911, 5D922, 5D1019, 5D1097, 5D1098, 5D1209, 5D1221, 5D1275, 5D1306, 5D1323, 5D1324, 5D1326, 5D1335, 5D1363, and 5D1370, exhibits which have previously been marked for identification, have now been received and uploaded to eCourt. It thus requests the admission of these documents along with their translations.<sup>1</sup>
- 2. On 27 November 2007, 5D690 was admitted into evidence despite concerns regarding the completeness of its translation.<sup>2</sup> The Lazarević Defence seeks to have another translation admitted, and yet remains silent as to what should be done with the original translation. The Chamber notes that the purported new translation of 5D690 seems to be identical to the previous, incomplete translation and that the table on the second page remains untranslated.
- 3. The Chamber notes also that the exhibit designated 5D1363 appears to have two identical versions of the original document.<sup>3</sup>
- 4. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS as follows:
  - (a) 5D199, 5D208, 5D215, 5D319, 5D666, 5D670, 5D675, 5D687, 5D910, 5D911, 5D922, 5D1019, 5D1097, 5D1098, 5D1209, 5D1221, 5D1275, 5D1306, 5D1323, 5D1324, 5D1326, 5D1335, and 5D1370 shall be admitted into evidence, along with their translations.
  - (b) The Lazarević Defence shall, in a written filing within seven days of the date of this Order, clarify its position in relation to 5D1363 and remove any superfluous versions from eCourt.

(c) The Lazarević Defence shall, in a written filing within seven days of the date of this Order, clarify its position in relation to 5D690, including informing the Chamber and the parties whether a revised translation should be uploaded to eCourt.
