- 3. the trial proceedings shall continue with the opening statements of the Defence for the Accused, should the Defence elect to make their opening statement at this stage of the proceedings, rather than after the conclusion of the Prosecution's presentation of evidence and before the presentation of evidence for the defence, as permitted in Rule 84 of the Rules.
