NOTING the "Order Reassigning a Case to a Trial Chamber", filed by the President of the Tribunal on 22 November 2006, assigning, with immediate effect, the case *Prosecutor v. Ante Gotovina et al.*, Case No. IT-06-90-PT, to Trial Chamber I;

NOTING the "Order Regarding Composition of Trial Chamber and Designating a Pre-Trial Judge", filed 23 November 2006, wherein the Presiding Judge of Trial Chamber I order the pre-trial bench to be composed of Judge Alphons Orie, Judge Christine Van den Wyngaert and Judge Balkone Justice Moloto, with Judge Balkone Justice Moloto designated as Pre-Trial Judge;

NOTING the "Order Designating a Pre-Trial Judge", filed 11 December 2007, wherein the Presiding Judge of Trial Chamber I designated himself, Judge Alphons Orie, to be the Pre-Trial Judge;

NOTING the "Order Assigning *Ad Litem* Judges to a Case before a Trial Chamber", filed by the President of the Tribunal on 3 March 2008, assigning Judge Uldis Kinis and Judge Elisabeth Gwaunza to Trial Chamber I "for the trial of Case No. IT-06-90, The *Prosecutor v. Ante Gotovina et al.*, effective, today, 3 March 2008";

NOTING that Judge Elisabeth Gwaunza made her solemn declaration pursuant to Rule 14(A) of the Tribunal's Rules of Procedure and Evidence ("Rules") on 3 March 2008, and that Judge Uldis Kinis is scheduled to make his solemn declaration on 10 March 2008 at 0845 hours;

CONSIDERING that Judge Uldis Ķinis cannot form a part of the composition of the trial bench until such time as he has made a solemn declaration pursuant to Rule 14(A) of the Rules;

CLARIFYING that the Trial Chamber in the case of *Prosecutor v. Ante Gotovina et al.*, Case No. IT-06-90-PT remains composed of Judge Alphons Orie, Judge Christine Van den Wyngaert and Judge Balkone Justice Moloto, with Judge Alphons Orie designated as Pre-Trial Judge, until such time as both *Ad Litem* Judges assigned to the case by the President for trial have made solemn declarations;
